same volunteers who are involved in the process of creating Electoral Rolls are also pushing people and creating awareness about the said program, the program is not a government program but a politically motivated program and is a part of the election campaign of the Current Ruling party in the State of Andhra Pradesh. It is pertinent to note that there is an obvious partisan bias of the Volunteers engaged in the activity of preparing electoral rolls and especially given that volunteers hold such an important database and also the profiling done by them over the last 4 years will lead to a tainted and an undemocratic electoral roll.

Pradesh, the employees in the post of teachers were the mainstay of electoral vote verification and enrolment program. They were also well trained, objective and fair with full appreciation of the responsibility devolved on them. They had discharged this responsibility with aplomb. It is pertinent to note that Complaints were nonexistent and there was transparency and they discharged their duties with only a view to maintain democratic values in the election process. It is further to be noted that while neither the ECI nor the

constitutional courts have made any observation regarding the continuation of this tested practice, the Government of AP had Suo moto sent a proposal to ECI and obtained permission from ECI by misrepresenting the facts and secured the concurrence for deployment of ward secretariat staff as replacement for teachers in the critical task of electoral roll verification and the just concluded comprehensive door to door survey, thereby compromising the sanctity of the Electoral Roll by undertaking various devious activities in the preparation of the same and also making use of the data that has been collected by them to delete the votes of the People that were known sympathizers of the opposition parties in the State of Andhra Pradesh.

57. It is submitted that the Mukesh Meena, Chief Electoral Officer stated on 04.10.2023 that the village and ward volunteers will not be drafted for any kind of election related duties in the State. He further stated that stern action will be taken against the officials if they use the services of ward and village volunteers in the Election Commission related work. It clearly depicts that the Election Commission itself does not want them to be a part of the free and fair process of election in the democracy or else they will hamper the process. A copy

of the Hans India Newspaper Report published on 04.10.2023 is annexed hereto and marked as **ANNEXURE P - 14**. .(Page No. 119-120)

- 58. It is further submitted that While the Chief Election Officer, AP had explicitly prohibited volunteers to take part in any manner, the volunteers were actively acting in concert with ward secretariat staff. In a few cases where the volunteers were on record associated with the verification program, the CEO AP perforce had suspended them. This is nothing but tokenism and the fact remains that the verification program is tainted due to their participation and insidious influence exerted. The ward secretariat was largely responsible for the major anomalies which are now part of public record. A large number of voters who are supporters of opposition groups disenfranchised without brazenly following were procedure of law and in violation of Principles of Natural Justice, i.e., issue of Form -14 & due opportunity.
- 59. It is humbly submitted that most recently the ECI had enquired into the issue of deletion of several thousands of voters from the voter list in the Uravakonda Assembly constituency of Anantapur district, The same came into light

when the same was taken up and represented by a legislator of the opposition and the ECI restored the votes illegally removed with the active connivance of ward secretariat staff and volunteers. The then ERO responsible was suspended. It is pertinent to note that the real culprits i.e., Village and Ward secretariat staff who were involved in this were not enquired into and no disciplinary action is being taken against them.

- 60. It is submitted that in the background of the spate of complaints arising out of the colorable actions that are entrusted to the same delinquents, The ends of justice will be ill served. It is submitted that the situation has amounted to a common belief among the citizens of the State of Andhra Pradesh that there is little faith in restoration of legitimate claims.
- 61. It is submitted that unless the known and admitted defects in the system are rectified the electoral rolls would be devoid of sanctity. It is pertinent to note Electoral rolls are the foundation of free and fair elections. A flawed exercise in addressing electoral rolls vitiates free and fair elections thereby killing the spirit of democracy in a country that prides itself as being the largest democracy in the world. It is

submitted that the entrustment of grievances and appeals of disenfranchised voters should not be entrusted to the same machinery, i.e., The Volunteers for redressal. It is submitted that the actions of the Village & Ward Volunteers have not left an iota of doubt that they are politically inclined and working towards the interest of the ruling regime. It is further submitted that the volunteers have also been found to have been indulging in activities such as threatening beneficiaries of the Government schemes of not only losing the benefits of the schemes but also their Right to vote, if they do not submit to the regime. It is pertinent to note that this action borders on criminal intimidation and is punishable by the Penal code.

62. It is submitted that in the past teachers were the mainstay of the electoral roll verification and the Government have deliberately kept them away only to replace them with ward & village secretariat staff who are totally partisan and don't inspire the confidence of voters whereas in contrast, the teachers are highly respected and non-partisan members of the State. The verification done by teachers in the past was fair & objective. It is pertinent to note that the complaints if at

all were far & few & not systemic in nature as is the present case.

- 63. It is submitted that the large numbers of the volunteer force at the rate one for every 50 households being involved in the election process and in voting would lead to an increased chance of post electoral violence, if the voting of the households under their watch do not take place in the predicted pattern. It is pertinent to note that the ECI had in the recent past dealt with such an extraordinary contingency which justifies the disbandment of volunteers who are the paid goons of the ruling regime.
- 64. It is further submitted that, it is a matter of grave urgency and injustice as the ECI themselves vide Letter No.1350/Elecs.B/A1/2023-2, Dt.08.09.2023, admitted that there are some serious anomalies, like large number of electors being enrolled in a single door number, electors being enrolled without any door number. It was also further noted by them that data of house numbers having junk number, zero number etc. were present and nearly 24 Lakh voters were present in the State, that have been enrolled under these suspicious circumstances. It is pertinent to note that, the

above discrepancies have arisen only after deployment of Ward and Village Volunteers in the election related processes and their insidious participation in the process of voter enrolment and preparation of voter lists, and the same is an alarming situation and needs rectification at the earliest and it is reliably suspected that there is an involvement of the Village and Ward Volunteers in the said discrepancies. A copy of the Letter No.1350/Elecs.B/A1/2023-2 dated 08.09.2023 is annexed hereto and marked as **ANNEXURE P - 15**.(Page No. 121-122)

# **GROUNDS**

The present Writ Petition is being filed on the following grounds and without prejudice to one another, in addition to further grounds that the petitioner craves leave to raise at the time of hearing:

A. It is submitted that, the ECI's action to link or seed voter information with data from Aadhaar and State Resident Data Hub (SRDH) is an unconstitutional profiling of voters. The 9 Judge Bench of this Hon'ble Court in *K S Puttaswamy vs. Union of India*<sup>1</sup>, recognized data minimization and purpose

limitations essential to preserve the right of privacy from unwarranted governmental invasion. Here, the ECI failed to justify a lawful purpose to link voter information with details of Aadhaar number and SRDH data. Likewise, the ECI failed to show the necessity to authenticate voter records through Aadhaar and SRDH data, either in place of, or in addition to, existing verification mechanisms (through field surveys by BLOs).

- B. It is submitted that, the ECI has effectively created a surveillance architecture given that the Aadhaar database and SRDH contains sensitive information voters, including religion, caste, tribe, ethnicity, language, records of entitlement, income, and medical history, is now linked to voter information.
- C. It is submitted that, the voter profiling allows political actors to segment people into 'interest groups' and either selectively target or ignore them from the electoral process, all of which interferes with free and fair conduct of election.
- D. It is submitted that, by applying the test of proportionality laid down by the Hon'ble Court to evaluate privacy violations.

For one, the ECI failed to show any valid law, rule, or notification to create linkages between EPIC and Aadhaar and SRDH data. Two, the ECI failed to establish a nexus between electronic linkages and voter verification. Three, the ECI failed to show that such voter profiling is necessary for verifying voter records, and that no other effective method or solution exists to achieve the stated goal. Finally, and more importantly, the ECI failed to justify the burden on privacy rights is proportionate stricto senso to their stated goals.

- E. It is submitted that, the ECI allowed the state government to access EPIC data without valid authority or sought the consent of voters.
- F. It is submitted that, the ECI has allowed the right to secrecy of vote to be compromised by linking voter records with information sources controlled and maintained by government agencies. It is further submitted that the ECI alone is entrusted with the mandate to hold elections in India. The Constitution, furthermore, exclusively reserved the authority to prepare electoral rolls to the ECI. The ECI's attempt to delegate its responsibility to prepare voter lists

using information sources under the control of government agencies is extra-constitutional.

- G. It is submitted that, the abdication of responsibility by the ECI not only resulted in large scale voter deletions in Andhra Pradesh, but further allowed political parties in Andhra Pradesh access sensitive information from SRDH including voter data during the General Elections of 2019. In fact, a Special Investigative Team was constituted by Telangana police to look into the voter profiling and data breaches of SRDH in 2019.
- H. It is submitted that, the ECI deleted voters from the electoral rolls without disclosing the algorithm, source-code of their deduplication software to the public. The deduplication software has. in the led widespread past, to disenfranchisement of voters. In 2015, a similar exercise conducted in Bihar using the software identified 37,54,648 voters as duplicates, while only 2,47,789 voters (8%) were found to be duplicate voter entries after field verification. And three years later, the adverse impact of deduplication was seen in Hyderabad during the state elections in December 2018 when a large number of voters found their names deleted from the rolls on the day of elections at the polling stations.

# I. The Hon'ble Court in Lal Babu Hussein v Electoral Registration Officer<sup>2</sup>, held that:

".... If the opportunity of being heard before deletion of the name is to be a meaningful and purposive one, it goes without saying that the person concerned whose name is borne on the roll and is intended to be removed must be informed why a suspicion has arisen in regard to his status as a citizen of India so that he may be able to show that the basis for the suspicion is ill-founded. Unless the basis for the doubt is disclosed, it would not be possible for the person concerned to remove the doubt and explain any circumstance or circumstances responsible for the doubt."

Per *Lal Babu Hussein*, the affected voter has the right to know the circumstances or grounds for the suspicion. The ECI, in this instance, has neither explained the basis for deleting voters nor have they disclosed the algorithm, source-code which makes it impossible for voters to learn about the "basis for the suspicion". In any event, mere similarities between two or more entries amongst millions of voters alone is insufficient to flag them as suspicious voters.

J. It is submitted that, the right to vote encompasses the right to not have an excessive administrative burden that impedes or deprives the right to vote. In failing to inform the affected voter, and without specifying the reasons for deletion, the ECI unlawfully placed the burden on voters to prove that they are neither duplicate nor shifted nor a dead voter. There would be considerable injury which would be caused to the public

in case if the citizens are deprived of their valuable right to vote.

- K. Therefore, unless or until, this Hon'ble Court suspends the operation of G.O.Ms.No.104, PANCHAYAT RAJ & RURAL DEVELOPMENT (MDL-I) DEPARTMENT dated 22.06.2019 issued by the Respondent 2 for Positioning of Village Volunteers @ one per around 50 households in the entire state of Andhra Pradesh, the Petitioner herein as well as the public at large will be put to irreparable loss, injury and grave injustice as their fundamental as well as constitutional rights are being violated. It is further submitted that, In the efficacy of fairness and natural justice, independent and objective functionaries are to be entrusted with the duty of preparing electoral rolls with immediate effect in grievance redressal and to restore credibility as well as to serve the ends of justice and any non-government servant with partisan bias such as Volunteers must be kept away from the said process. The balance of convenience is in favor of the Petitioner and the general public, and prima facie case is made out for the grant of ad-interim order.
- L. The Petitioner had also sent a representation to the State Government addressing the issue raised in this Petition, and was seeking intervention of the Respondent in addressing the issues. The Petitioner however never received any reply or corrective measures from the side of Respondent the said representation.

M.The present writ petition, under Article 32 of the Constitution of India, is being filed in public interest, to raise issues which endanger Fundamental Rights of citizens of India, protected under Articles 21 and 243 of the Constitution of India. Having regard to the nationwide implications of the important issues raised in this petition, this Hon'ble Court ought to entertain and hear the present petition. The Petitioners state that they have not filed any other similar petition challenging the impugned Ordinance before this Hon'ble Court or any High Court.

# **PRAYER**

In View of the Facts and circumstances mentioned above, it is most respectfully prayed that this Hon'ble Court may be pleased to issue a Writ of Mandamus or any other appropriate Writ;

# Prayers concerning Village/ward volunteers

- a. SET ASIDE the impugned G.O.Ms.No.104, PANCHAYAT RAJ & RURAL DEVELOPMENT (MDL-I) DEPARTMENT dated 22.06.2019 as being illegal, arbitrary, unconstitutional and violative of Articles 21, Article 243 of the Constitution of India;
- b. TO RESTRAIN/PROHIBIT the functionaries of the illegally recruited and partisan based Village and Ward Volunteer functionaries from involvement in the process of preparation of Electoral Related functions;
- c. TO DIRECT the Election Commission of India to utilize the services of the employees of the Government and

teachers for the preparation of Electoral Rolls and for

the Conduct of a Free and Fair Elections.

Prayers against the illegal data usage

d. TO CONSTITUTE an empowered technical committee

to examine the allegations of data breach and profiling

by the State Government of Andhra Pradesh through

collection of data by Gram Volunteers/ward

volunteers and the involvement of certain

  - (i) any jagir, inam or muafi or other similar grant and in the States of Tamil Nadu and Kerala, any janmam right;
    - (ii) any land held under ryotwari settlement;
  - (iii) any land held or let for purposes of agriculture or for purposes ancillary thereto, including waste land, forest land, land for pasture or sites of buildings and other structures occupied by cultivators of land, agricultural labourers and village artisans;
- (b) the expression "rights", in relation to an estate, shall include any rights vesting in a proprietor, sub-proprietor, under-proprietor, tenure-holder, raiyat, under-raiyat or other intermediary and any rights or privileges in respect of land revenue.
- 31B. Validation of certain Acts and Regulations.—Without prejudice to the generality of the provisions contained in article 31A, none of the Acts and Regulations specified in the Ninth Schedule nor any of the provisions thereof shall be deemed to be void, or ever to have become void, on the ground that such Act, Regulation or provision is inconsistent with, or takes away or abridges any of the rights conferred by, any provisions of this Part, and notwithstanding any judgment, decree or order of any court or Tribunal to the contrary, each of the said Acts and Regulations shall, subject to the power of any competent Legislature to repeal or amend it, continue in force.
- **31C.** Saving of laws giving effect to certain directive principles.—Notwithstanding anything contained in article 13, no law giving effect to the policy of the State towards securing <sup>1</sup>[all or any of the principles laid down in Part IV] shall be deemed to be void on the ground that it is inconsistent with, or takes away or abridges any of the rights conferred by article 14 or article 19; <sup>2</sup>[and no law containing a declaration that it is for giving effect to such policy shall be called in question in any court on the ground that it does not give effect to such policy]:

Provided that where such law is made by the Legislature of a State, the provisions of this article shall not apply thereto unless such law, having been reserved for the consideration of the President, has received his assent.

**31D**. [Saving of laws in respect of anti-national activities.] Rep. by the Constitution (Forty-third Amendment) Act, 1977, s. 2 (w.e.f.13-4-1978).

#### Right to Constitutional Remedies

- **32. Remedies for enforcement of rights conferred by this Part**.—(1) The right to move the Supreme Court by appropriate proceedings for the enforcement of the rights conferred by this Part is guaranteed.
- (2) The Supreme Court shall have power to issue directions or orders or writs, including writs in the nature of *habeas corpus*, *mandamus*, prohibition, *quo warranto* and *certiorari*, whichever may be appropriate, for the enforcement of any of the rights conferred by this Part.

- (3) Without prejudice to the powers conferred on the Supreme Court by clauses (1) and (2), Parliament may by law empower any other court to exercise within the local limits of its jurisdiction all or any of the powers exercisable by the Supreme Court under clause (2).
- (4) The right guaranteed by this article shall not be suspended except as otherwise provided for by this Constitution.
- **32A**. [Constitutional validity of State laws not to be considered in proceedings under article **32**.] Rep. by the Constitution (Forty-third Amendment) Act, 1977, s. 3 (w.e.f. 13-4-1978).
- **33.** Power of Parliament to modify the rights conferred by this Part in their application to Forces, etc.—Parliament may, by law, determine to what extent any of the rights conferred by this Part shall, in their application to,—
  - (a) the members of the Armed Forces; or
  - (b) the members of the Forces charged with the maintenance of public order; or
  - (c) persons employed in any bureau or other organisation established by the State for purposes of intelligence or counter intelligence; or
  - (d) person employed in, or in connection with, the telecommunication systems set up for the purposes of any Force, bureau or organisation referred to in clauses (a) to (c),


be restricted or abrogated so as to ensure the proper discharge of their duties and the maintenance of discipline among them.

- 34. Restriction on rights conferred by this Part while martial law is in force in any area.— Notwithstanding anything in the foregoing provisions of this Part, Parliament may by law indemnify any person in the service of the Union or of a State or any other person in respect of any act done by him in connection with the maintenance or restoration of order in any area within the territory of India where martial law was in force or validate any sentence passed, punishment inflicted, forfeiture ordered or other act done under martial law in such area.
- **35.** Legislation to give effect to the provisions of this Part.—Notwithstanding anything in this Constitution,—
  - (a) Parliament shall have, and the Legislature of a State shall not have, power to make laws—
  - (i) with respect to any of the matters which under clause (3) of article 16, clause (3) of article 32, article 33 and article 34 may be provided for by law made by Parliament; and
  - (ii) for prescribing punishment for those acts which are declared to be offences under this Part,

and Parliament shall, as soon as may be after the commencement of this Constitution, make laws for prescribing punishment for the acts referred to in sub-clause (ii);

(b) any law in force immediately before the commencement of this Constitution in the territory of India with respect to any of the matters referred to in sub-clause (i) of clause (a) or providing for punishment for any act referred to in sub-clause (ii) of that clause shall, subject to the terms thereof and to any adaptations and modifications that may be made therein under article 372, continue in force until altered or repealed or amended by Parliament.

Explanation.—In this article, the expression "law in force" has the same meaning as in article 372.

- 8. To recruit, employ, appoint required technical, financial, administrative and other manpower for the functioning of the society and to pay them from the funds of the society. To buy required equipment and furniture.
- 9. To negotiate and enter into agreements and contracts with any entity for technical, financial or any other such assistance for carrying out all or any of the objects of the society.
- 10. To undertake any other activity incidental to further the cause of above objects.

#### 5. GENERAL BODY:

The General body of the society shall consist of all the members of the society.

# 6. MANAGEMENT:

#### 7. AMENDMENT:

# BYELAWS OF CITIZENS FOR DEMOCRACY

# 1. NAME OF THE SOCIETY:

The society shall be known as 'Citizens for Democracy'

#### 2. ADDRESS OF THE SOCIETY:

The Registered office of the Society will be situated at 4-2-5/6, 2<sup>nd</sup> Floor Ramannapeta, 1<sup>st</sup> line Koratipadu, Guntur - 522007

#### 3. MEMBERSHIP:

- (i) membership or addition of new members shall be subject to the approval of the Executive Committee.
- (ii) membership in the Executive Committee of any member may be revoked through a resolution in the General Body on grounds of health, unsoundness of mind or actions repugnant to the objectives of the Society or on grounds of conduct unbecoming of a member.
- (iii) Whenever a member desires to resign from membership of the Executive Committee or to the general body it shall take effect on its acceptance by the Chairman of the Executive Committee.
- (iv) The society shall have only one category of members.
- (v) The annual membership fee of the members shall be decided by executive committee from time to time and the same shall be paid by the members within 60 days of the commencement of the financial year.

# 4. FUNCTIONS OF THE GENERAL BODY:

- (i) The General Body shall provide overall policy guidance and directions for the efficient functioning of the society in fulfilling its objects as laid down in the Memorandum of Association.
- (ii) It shall meet at least once in every financial year in the month of September excluding the financial year in which it is incorporated / registered.
- (iii) It shall consider and adopt the annual audited accounts of the society and report of the activities of the society presented by the Executive Committee.
- (iv) It shall approve the Annual Action Plan and budget for the ensuring year.
- (v) It shall elect the Executive Committee for the society once in five years.
- (vi) It shall appoint the auditors for the society.

# 5. FUNCTIONS AND POWERS OF THE EXECUTIVE COMMITTEE:

The Executive Committee shall have the power:

- (i) To undertake all activities necessary for the fulfillment of the objects as laid down in the Memorandum of Association.
- (ii) To expand the strength of its membership
- (iii) To approve and recommend to the General Body to add, modify or amend the Memorandum of Association and these bye-laws provided that all such additions, modifications or amendments shall be aimed at promoting the objects of the Society.
- (iv) To remove a member on the grounds as it deems fit.
- (v) To acquire movable and immovable properties by purchase, lease, hire or otherwise, to construct, alter and maintain them, and to dispose them as it deems fit.
- (vi) To approve and recommend for adoption by the General Body the annual report and the annual audited accounts of the society
- (vii) To approve and recommend the appointment of the auditors of the society and fix their remuneration.
- (viii) To meet at least once in every calendar quarter
  - (ix) To convene a General Body meeting within thirty days of receipt of a requisition for convening a meeting signed by at-least one third of the members of the society and any such requisition shall contain the proposed agenda and the reasons for such meeting.
  - (x) To borrow / raise funds for the fulfillment of its objects, wherever necessary and to invest the funds of the society in bank deposits and other securities.
  - (xi) To accept donations, transfer of assets, devolutions for the fulfillment / furtherance of its objects
- (xii) To recruit, employ, appoint required technical, financial, administrative and other manpower for the functioning of the society and to pay them from the funds of the society.
- (xiii) To negotiate and enter into agreements and contracts with any entity for technical, financial or any other such assistance for carrying out all or any of the objects of the society.
- (xiv) The members of the Executive Committee shall be duty bound to attest the signatures of all the members of newly elected Executive Committee and to see that the said signatures of the out going Committee tally with the annual list as filed with the Register of societies before 15 days of the succeeding month in which elections were held

# 6. FUNCTIONS AND POWERS OF THE OFFICE BEARERS:

## **President:**

The functions and powers of the President of the Executive Committee are:

- I. To convene / call meetings of the Executive Committee
- II. To preside over the meeting of the Executive Committee and General Body and to have a casting vote in case of a tie.
- III. To decide on the exclusions from the minutes of the meeting and sign the minutes

IV. To accept resignation of the member of General Body / Executive Committee when offered

# **VICE-PRESIDENT:**

He shall assist the president in discharging his duties. In the absence of the President he shall perform the duties of the President as entrusted by him.

#### SECRETARY:

- I. He is the Executive Officer of the society and custodian of all records relating to the society and correspondent on behalf of the society.
- II. He has to record and maintain all minutes of the meetings of the society
- III. to convene the meetings of Executive Committee and General Body of the society with the permission of the President.
- IV. He shall guide the treasurer in preparing the budget and expenditure statement of the society.

# JOINT SECRETARY:

- I. He has to do the work as entrusted by the executive
- II. committee.
- III. He has to assist the Secretary in discharging his duties.
- IV. In the absence of the secretary, he shall perform the duties of the secretary.

#### TREASURER:

- I. He is responsible for all-financial transactions and funds of the society.
- II. He has to maintain accounts properly along with the vouchers
- III. He has to operate the bank accounts of the society jointly with the Secretary or President.

#### 7. MEETINGS:

- (i) Meetings of the General Body and the Executive Committee shall be notified 7 days and 3 days in advance of the date set for the meetings respectively
- (ii) Quorum for the meetings of the General Body shall be 50% of the total members and that of the Executive Committee shall be 25% of the committee members.
- (iii) The agenda for the meetings of the Executive Committee shall be finalized by the General Secretary. Any member proposing an item for the agenda shall give notice thereof to the General Secretary 7 days in advance of the meeting.
- (iv) Each member of the General Body and the Executive Committee shall have one vote each and in the event of an equality of votes on any question, it shall be decided by the casting (additional )vote of the chairman.
- (v) The General Secretary shall keep a record / Minutes of the proceedings of the meetings of the Executive Committee and the General Body. He shall communicate the minutes of the Executive Committee meetings, signed by the President, to all the Committee members within 30 days from the date of the meeting.
- (vi) Any business required to be conducted by the Executive Committee may also be conducted by a resolution in writing circulated among all its members and any

such resolution so circulated and approved by a majority of members signing shall be as effective and binding as a resolution passed at a meeting of the Committee.

# 8. FUNDS OF THE SOCIETY:

The banker / bankers of the Society shall be decided by the Executive Committee.

All funds of the Society should be paid into Society's account with the said (ii) banker(s). The said bank account(s) shall be operated by the Treasurer with the joint signatures of either the President or the General Secretary.

# 9. ACCOUNTS AND AUDIT:

The Society shall keep at its registered office proper books of account in which should be entered accurately all sums of money expended by the Society and the object or purpose for which such sums are expended.

The accounts of the Society shall be audited by a Chartered Accountant to be (ii)

appointed by the General body.

Every member of the Executive Committee shall have the right of inspection of (iii) accounts and registers maintained by the Society and proceedings of the meetings of the Society at any time during office hours.

# 10. ANNUAL REPORT:

An Annual Report of the proceedings of the Society and of all work undertaken during the year shall be prepared by the Executive Committee for the information of the members and shall be placed before the General Body of the Society at the Annual General Meeting.

Within 15 days after the holding of Annual General Meeting there shall be filed, with the Registrar of Societies (I) a list of names, addresses and occupations of the members of the Executive Committee; (ii) an annual report of the previous year;

# 11. PROPERTY OF THE SOCIETY:

All property belonging to the Society shall be deemed to be vested in the (i) Executive Committee of the Society but shall be referred to as 'the property of the Society'.

The income and property of the Society shall be applied towards the promotion of (ii)

the objects as set forth in the Memorandum of Association.

# 12. SUITS AND PROCEEDINGS BY AND AGAINST THE SOCIETY:

The Society is a body corporate with a separate legal entity and hence (i) may sue or may be sued and may be represented by the General Secretary or any other officer authorized by the Executive Committee in this behalf

- Every decree of order against the Society in any suit or proceedings (ii) shall be executable against the property of the Society and not against the person or the property of any officer or member of the Society.
- Every member of the Society may be sued or prosecuted by the (iii) Society for any loss or damage caused to the Society or its property or for anything done by him intentionally which is detrimental to the interests of the Society

These objectives s are aligned with the objectives of the ECI itself. The aims, objectives and the particulars of founders is enclosed.

CFD had its launch function at Vijayawada AP with Sri VS Sampath former CEC who enlightened about the various pro active measures taken by ECI towards free and fair elections.

CFD is seized of widespread concerns prevailing regarding the defects apparent and persisting in electoral roll preparation in AP despite several remedial measures taken by CEO AP which we are appreciative.

The root cause of the problem relates to enrolment of bogus voters as well as deletion of bonafide voters without following due procedure ie issue of Form - 14 with the active connivance of low level Govt functionaries ie village secretariat staff & village volunteers. The ECI is alive to the plight of a large number of migrant labourers and the consideration required not to delete them on grounds of non response or absence during visits of BLO! The ECI itself is sympathetic of their hardship and came with initiatives! These cases need to be dealt with special consideration.

Overall the Govt servants are acting under undue pressure either wilfully or otherwise. Added to this dimension is the spectacle village secretariat staff acting as BLO 's and village secretaries playing an active role behind the scenes. At the outset it would appear that most of them have neither the experience nor the maturity to deal with a critical matter of dealing with an important issue involving right to vote.



(Regd. vide 313 of 2023 Societies Act)

It is pertinent to point out that the State Election Commission of AP had taken a conscious decision in the recent past to keep out volunteers from election process after due application of mind that they are partisan and have a motive to promote political interests. The same holds good for village secretariat staff as well particularly in the light of recent C& AG observations which castigated the village secretariat functioning as violative of 73 rd & 74 th amendments. The Govt had just announced that the village secretariat staff and volunteers are going to be part of a major outreach programme from 11 th October for one month in which all the political functionaries of the ruling YSRCP party are involved. This is a political programme to further political prospects.

Prima facie it would appear that a substantial number of genuine Form 7's already filed are not disposed off on merits. At the same time bulk Form 7 's are filed for political ends by circumventing the limits prescribed. At the same time deletions are effected in a substantial number of cases without following due procedure despite protests.

The CDF is appreciative of the Anantapur district episode which was taken due note by ECI. This is not an isolated case in as much as the malice has spread wide!

Unless electoral rolls are cleaned up, the ends of free and fair elections advocated by ECI will not be served. The cleaning up of electoral rolls is to be initiated immediately as elections are underway!

The solution CDF would like to offer is to keep volunteers and village secretariat staff completely away from electoral roll preparation process due to their tainted background and deep rooted political affiliation. If the complaints are referred back to the same machinery, ends of justice will not be served at all. They are the root cause behind many of these complaints.

In the past teachers who are experienced and impartial were entrusted with this responsibility and complaints were non existent largely. They are a tested & reliable machinery and it's not known why they are deliberately kept away at present.

The CFD is of the considered view to bring back teachers to deal with all the pending and unresolved complaints so as to restore the sanctity to electoral roll preparation. Unless timely measures are resolutely taken, the election process in AP will be significantly flawed.

CFD urges immediate corrective steps and set at rest the serious doubts that are persisting in the minds of the electorate, the media and public at large.

#### ORDER:

Government is committed to revamp delivery systems in the State with an aim to improve living standards of the people through the concept of NAVARATHNALU as core theme of governance. In order to operationalize Navarathnalu, Government intends to deploy Volunteers in rural areas for delivering Government Services at door step of all eligible households irrespective of Caste/Creed/Religion/Gender and political affiliation. This system will ensure leak proof implementation of Government Programmes/Schemes. The objective of positioning Village Volunteers is to ensure timely and transparent services, to eliminate the corruption at all levels of administration. Village Volunteers will identify the problems being faced by anybody in his jurisdiction and the same will be brought to the notice of Gram Panchayat and then get them resolved.

2. Accordingly, the Commissioner, PR & RD has submitted proposals on procedure for selection, imparting training and positioning of the Volunteers and requested to permit for commencing the process for selecting Volunteers @ one per around 50 households in the State by 15<sup>th</sup> August, 2019. Further, he has also requested to permit him to incur an expenditure of Rs.13.50 Cr. (Rupees Thirteen Crores and Fifty Lakhs Only) for recruitment and training and Rs.1,200 Cr. (Rupees One thousand Two Hundred Crores Only) per annum for payment of honorarium to positioned volunteers @ Rs.5,000 /- per volunteer per month. He has formulated the following guidelines for positioning of Village Volunteers.

# I. NOTIFICATION:

The Notification shall be issued in Telugu in two Telugu Daily News Papers by the District Collectors concerned.

# II. NUMBER OF VOLUNTEERS:

The Number of volunteers shall be arrived by the respective District Collectors.

# III. ELIGIBILITY:

The applicant must belong to the village/Gram Panchayat for which she/he is applying.

# IV. EDUCATIONAL QUALIFICATIONS:

The applicant must pass Intermediate (or) its equivalent exam in plain areas whereas 10<sup>th</sup> Class or its equivalent pass in Agency/ Tribal Areas.

#### V. RESERVATION:

Rule of reservation is applicable as per the rules in vogue. 50% of posts within each category may be considered for women. **ROR** will be applicable considering Mandal as a unit.

#### VI. AGE:

The applicant shall have 18 years of age as on 30-06-2019 and shall have not exceeded 35 years.

#### VII. HOW TO APPLY:

The candidates shall apply online through Website link <a href="http://gramavolunteer.ap.gov.in">http://gramavolunteer.ap.gov.in</a>

#### VIII. METHOD OF SELECTION:

Positioning and Commencement of work by Village Volunteers in the village shall start from 15<sup>th</sup> August, 2019.

#### XII. ROLES AND RESPONSIBILITIES OF VILLAGE VOLUTEERS:

Roles and responsibilities of Village Volunteers will be determined by the Commissioner, PR&RD, AP.

#### XIII. MAPPING OF VILLAGES FOR VOLUNTEERS:

Mapping of Village dividing into territorial units @ 1 unit for 50 Households contiguously by the committee consisting of MPDO/Tasildhar/EO (PR&RD).

#### XIV. REVIEW MECHANISM/PERFORMANCE APPRAISAL:

MPDO at Mandal Level and Panchayat Secretary at Village Level will monitor the performance of village volunteers at frequent intervals.

The State Government constituted 15,004 secretariats, as an extension arm of the State Government, for implementation of various Government schemes/ services. The Secretariats are servicing across 13,000 plus villages and 120 ULBs in the State. With over 1.34 Lakhs Village/ Ward Secretariat functionaries and 2.66 Lakhs Volunteers engaged in this new set-up, the Department is monitoring service delivery of over 543 plus services to the citizens.
- 6. Government of Andhra Pradesh envisions the Secretariats to become "One Stop Solution" to address all the requirements of the citizens and address grievances pertaining to service delivery. The Department foresees to augment the service delivery by adopting citizen-centric service delivery model by including below services:
  - i. Set up Aadhar Centers, Branch post offices, facility of Sub- Registration in all Secretariats etc.
  - ii. GOI services with necessary tie-ups with CSC and other institutions and augmenting service delivery by providing services related to Passport, B2C etc.
- 7. It was felt that there is a need for proper coordination between the local Gram Panchayat and the Village Secretariat(s) which serves as an extension arm of the State Government since the Secretariats provide around 543 plus services relating to various State Government Departments. The roles and responsibilities of the various Village Secretariat functionaries need to be defined properly so as to ensure proper coordination between the Gram Panchayat and the Village Secretariat(s). This Department has conducted multiple deliberations with various Line Departments like Agriculture, Panchayat Raj, Municipal Administration, Revenue, Energy etc. and also with District Collectors and District Level Officers of some of the Districts to ensure better convergence and coordination between Gram Panchayat and Village Secretariat(s).

- 8. To ensure better service delivery through the Village Secretariats and to ensure better coordination between Gram Panchayat and Village Secretariat(s) in public interest, the Director, GVWV & VSWS has proposed certain modifications in the references (2), (3) and (4) read above regarding the Executive, Drawing and Disbursement and Administrative Functions of Functionaries in the Village Secretariats.
- 9. Government after careful examination of the proposal of the Director, GVWV &VSWS Department and taking into consideration the views expressed by the Line Departments, District Collectors and District level officers, in partial modification of the GOs issued in the references (2), (3) and (4) read above hereby issues the following orders so as to ensure better service delivery and coordination between Gram Panchayat and Village Secretariat(s) in public interest.
  - i. **Executive functions:** Panchayat Secretary shall act as Executive Officer of the Gram Panchayat and shall function as a Link Officer between Gram Panchayat and Village Secretariat(s).

# ii. Drawing and Disbursement functions and Coordinator for implementation of Government Schemes:

- a. Panchayat Secretary (I to V) shall act as a Drawing and Disbursement Officer (DDO) for himself/ herself and existing Panchayat Staff (regular / outsourcing / contractual staff) of Gram Panchayat.
- b. Village Revenue Officer (VRO) shall act as a DDO for all the Functional Assistants in the Village Secretariat including Digital Assistant, except the Panchayat Secretary (Grade I to V) and existing Panchayat Staff (regular / outsourcing / contractual staff).
- c. VRO shall act as a Drawing and Disbursement Officer for drawing and disbursing of honorarium to the Grama Volunteers.
- d. VRO shall also act as a Coordinator for activities related to service delivery of Government Schemes and shall ensure effective implementation of State Government schemes / services being rendered by Village Secretariats.

#### iii. Administrative Functions:

- a. All Village Functional Assistants including Digital Assistants, except Panchayat Secretary (Grade I to V) and existing Panchayat Staff(regular/ outsourcing/ contractual staff), shall seek approval of Casual Leave from the respective Head of the concerned Department at the Mandal level and Casual Leave application shall be routed through VRO.
- b. Sarpanch is the competent authority to sanction Casual Leaves of Panchayat Secretary (I to V) and existing regular Panchayat Staff of Gram Panchayat.
- 9. The Director, GVWV & VSWS Department, HODs of concerned Departments and the Chief Executive Officer, APCFSS are requested to take necessary action.

# Return of FC funds to Panchayats demanded

Prakasam Zilla Panchayat Sarpanchula Sangam demands the government for cancellation of the memo issued for the collection of electricity charges from their own funds and finance commission funds

PRAKASAM Zilla Panchayat Sarpanchula Sangam staged a protest in front of the Collectorate here on Monday and submitted a representation to the Collector demanding the State government to return the funds to a tune of Rs 8,630 crore withdrawn from the 14th and 15th Finance Commission funds immediately. They also demanded the government to release the share of panchayats in the taxes and cesses pending from 2019 and continue providing free electricity to minor panchayats as given earlier by the former Chief Ministers.

Speaking at the protest, sarpanches leaders G Veerabhadrachari, R Sandhya, Ramasubbareddy, Y Rajasekhar Reddy, Atmarao, Bolineni Nageswara Rao and others said that since the elections held for panchayats in the State, the government didn't release even a single rupee to panchayats but withdrawn 14tj and 15th Finance Commission

funds of Rs 8,629.79 crore released to 12,918 panchayats across the State from 2018-19 to 2021-22 to utilise for its schemes, without the knowledge or authentication of the sarpanches. They said the government even didn't release Rs 4,041 crore funds from 15th Finance Commission for 2022-23 and 2023-24. They said that the government has to release about Rs 3,000 crore as the share of

the panchayats in the taxes and cesses and demanded immediate release.

They complained that the government is running a parallel system through its party by appointing volunteers, village secretariat, grihasaradhi system, and secretariat conveners and hijacking the panchayats' rights and powers against 73rd and 74th constitutional amendments. They demanded the government continue the earlier system of releasing NREGA funds to panchayats directly to facilitate sarpanches and gram sabha to decide the works to be taken up under the scheme. Farmers have to suffer hardships if the deficient rainfall continues in the

In all, 14 districts registered deficient rainfall. Only Krishna and Alluri Sitaramaraju districts registered excess rainfall this rainy season. The Rayalaseema region received lesser rains compared to the Coastal Andhra Pradesh.

According to the Meteorological department, 14 districts have registered a deficient rainfall. Anakapalli, East Godavari, NTR

district, Palnadu, Prakasam, Potti Sriramulu Nellore district and West Godavari districts in the coastal Andhra have recorded deficient rainfall. In the Rayalaseema region, Anantapur, Annamayyam, Chittoor, Kurnool, Nandyal, Sri Satyasai, Tirupati and YSR districts recorded deficient rainfall.

Tirupati district received only 77 mm rainfall against the normal rainfall of 160 mm from June 1 to July 24. It received 52 percent less rainfall compared to the normal rainfall.

East Godavari district reg-

istered only 194 mm rainfall against the normal rainfall of 292 mm rainfall since June 1 and it is 34 percent less than the normal rainfall.

Palnadu district received 30 mm deficient rainfall, Nellore district 39 percent deficient rainfall, West Godavari 30 percent deficient rainfall. Annamayya district received 35 mm deficient rainfall. It received only 87 mm rainfall against the 133 mm rainfall. Kurnool district received only 110 mm rainfall against the normal rainfall of 154 mm rainfall. YSR district received only

85 mm rainfall against the normal rainfall of 137 mm. On the other hand, only two districts recorded excess rainfall this rainy season. Krishna district recorded 381 mm rainfall against the normal rainfall of 270 mm. Alluri Sitaramaraju district received 450 mm rainfall against the normal rainfall of 368 mm.



Real-time governance, as a system, has evolved and been experimented with in both Telangana and Andhra Pradesh since 2014. Promoted by ex-UIDAI Chairman and bureaucrat J Satyanarayana, real-time governance involves real-time collection of information to facilitate a predictive form of governance.

In this setup, the government creates 360-degree profiles of every resident with an Aadhaar and provides them with everything they are entitled to – from subsidies to solving their broken electricity metres.
